This Memorandum of Understanding (hereinafter referred to as MoU) is made and entered into on this day, the 25th September 2025 between Career Guidance and Counselling Cell of Bar. Sheshrao Wankhede Mahavidyalaya situated at Mohpa, Tah. Kalmeshwar, Distt. Nagpur (hereinafter referred to as CGCC, BSWMM) and Mahatma Fule Study Circle, a wing of Mahatma Fule Bahuuddeshiy Sanstha with its registered office at Mohpa, Tah Kalmeshwar. Distt. Nagpur (hereinafter referred to as MFSCM) for a period of 05 years.

1. OBJECTIVES OF THE MOU

The objectives of this MOU are:

- To guide students on goal setting
- To create awareness about competitive examinations
- To instill competitive spirit into the students
- To prepare students for group discussion
- To train students to face personal interviews.

2. PROPOSED TERMS OF COLLABORATION

CGCC, BSWMM and MFSCM propose to collaborate in continuing Bar. Wankhede Academy established in the Academic Session 2025-26 in the College to prepare young aspirants for job-oriented competitive examinations on the following terms and conditions:-

- The aspirants will have to get themselves registered with Bar. Wankhede Academy by paying Rs. 100/- (Rupees one hundred) in cash.
- CGCC, BSWMM and MFSCM shall conduct classes of sixty minutes duration in the college on five days a week for a period of six months when there are no teaching classes for regular college students or after the teaching classes are over.
- The classes will be conducted during day time and will be free of cost.
- Bar. Sheshrao Wankhede Mahavidyalaya, Mohpa will provide 3 of its teachers out of Dr. Ajiet Jachak, Dr. Dhananjay Deote, Dr. Liladhar Kharपुरीये and Principal, Dr. Alka Thodge to engage classes while at least two others will be provided by MFSCM.
- Bar. Sheshrao Wankhede Mahavidyalaya, Mohpa will provide a classroom and other available facilities for these classes.

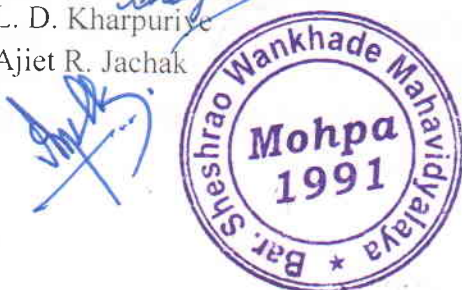

This memorandum of understanding (here in after referred as (MOU) is made and signed between:

This **Memorandum of Understanding** is intended to promote cooperation between the **Barrister Sheshrao Wankhede College, Mohapa Dist. Nagpur (First Party)**, and **Nagar Parishad Shivaji Mahavidyalaya, Mowad, Dist. Nagpur (Second Party)** represented by both the Principal recognizing the benefits to their respective institute from the establishment of institutional linkage, hereby agree to enter into this agreement for the following purpose.

1. PURPOSE OF AGREEMENT

The purpose of this agreement is to develop academic and educational cooperation, establish a collaborative program in (indicate area of cooperation) between the two colleges and to cooperate in their mutual interest for a range of higher educational activities.

2. AREAS OF COOPERATION

Subject to the availability of funds, resources and approval of the authorized representatives of Barrister Sheshrao Wankhede College, Mohapa and Nagar Parishad Shivaji Mahavidyalaya, Mowad, both institutions agree to develop the following collaborative activities:

- a. Conducting joint research and development project
- b. Cooperation in individual projects
- c. Organization of lectures, symposia, webinars, conferences, seminars and workshops.
- d. Exchange of faculty and students
- e. Exchange of information, teaching materials,
- f. Providing opportunities for teachers to give lectures
- g. Search for opportunities to collaborate in the future
- h. Resource sharing for research activities.
- i. Placement and execute training.
- j. To share library facilities

3. IMPLEMENTATION

- 3.1 All programs or activities implemented under the terms of this Memorandum of Understanding shall be mutually agreed upon in writing, including the necessary budget for the program of activity as the need may arise.
- 3.2 Each of the participating institutions shall be fully responsible financially for the activities carried out under its direction or by its staff, except as otherwise agreed by the parties.
- 3.3 The parties will designate one teacher each who will develop and coordinate specific programs or activities between them.

4. INTELLECTUAL PROPERTY

Intellectual property rights of work carried out at each partner institution shall normally vest with respective institution.

5. DURATION AND RENEWAL OF AGREEMENT

This Memorandum of Understanding will become effective immediately after day of signature by the Principal, Barrister Sheshrao Wankhede College, Mohapa and Principal of Nagar Parishad Shivaji Mahavidyalaya, Mowad for a period of **five Years** from academic session **2025-26 to 2030-31** and is subject to revision of modification by mutual agreement.

6. **AMENDMENTS**

- 6.1 The details for the efficacious implementation of this Memorandum of Understanding shall be jointly worked out on mutually acceptable terms within the parameters of the policies, rules and regulations of both the institutions.
- 6.2 This Memorandum of Understanding may be amended by a written agreement signed by the Principal of both colleges.
- 6.3 In the event of any unforeseen incident during collaborative activities in either country both colleges agree to negotiate a mutually acceptable solution.
- 6.4 Should any disagreement arise out of the application, interpretation or implementation of this Agreement, the college shall endeavor to exercise best efforts to negotiate their differences.

7. **TERMINATION OF AGREEMENT**

This agreement may, at any time during its period of validity, be terminated by either party upon prior notice to the other in writing not later than one month before termination date, provided that such termination shall not affect the completion of any program or activity underway at the time the notice of termination is given.

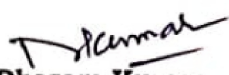
Following terms and conditions agreed by both the parties and affixed their signatures confirming the laid down terms and conditions about Library and Information Center.
